Apply in adequate spray volume to ensure good coverage. Repeat applications as needed. When tank mixing, determine compatibility by conducting a jar test. When tank mixing with phosphate fertilizers (avoid tank mixing with fertilizers that have high phosphate content), maintain vigorous agitation. The use of a non-ionic surfactant is recommended for increased plant uptake.
